**Federal Reserve and U.S. Treasury announce Main Street Lending program, a new payroll loan option for businesses affected by COVID-19.**

In a [press release](#) yesterday, the Federal Reserve and U.S. Treasury announced a new Main Street Lending program to provide further payroll assistance for small and midsized businesses affected by the coronavirus. NADA put together an [informative summary](#) of the new program, writing, "Eligibility for the Main Street Loan will be broader than under the Paycheck Protection Program (PPP)."

How does this work with the financial aid made available by the Coronavirus Aid, Relief, and Economic Security (CARES) Act? The Federal Reserve indicated PPP loan recipients may obtain Main Street Loans. In its summary, NADA adds, "While these loans will not have the extraordinarily favorable terms (such as forgiveness) found in the PPP loan program, the Main Street Loan program will provide another source of liquidity to keep people on the payroll." The national association says we can expect further guidance from both the Federal Reserve and Treasury.

**NADA alerts franchised dealer community to guidance and reminders from OSHA.**

As NADA provided, OSHA has also offered a bulletin on [Worker Exposure Risk to COVID-19](#) and videos on [Ways to Increase Social Distancing at Work](#) and how to [Use the Right Tools to Clean Your Workplace](#).




