Statement of Support for the Objectives of the VADA

ARTICLE II – OBJECTIVES

Sec. 1.

The objectives of the Association shall be:

- (1) To facilitate the exchange of ideas among its members.
- (2) To encourage sound business policies.
- (3) To foster constructive and progressive state legislation relative to the motor vehicle industry, including but not limited to legislation which (a) fosters competition through balance and fairness in the relationships between Association members and suppliers of the products Association members sell and service; and (b) defends the franchises of Association members to encourage investment in and development of businesses providing quality products and services to customers and the public.
- (4) To discourage destructive, retrogressive legislation, especially as it may effect the sale or operation of motor vehicles.
- (5) To cooperate with other motor vehicle trade associations.
- (6) To promote confidence, respect and good fellowship among all who are directly or indirectly engaged in the motor vehicle industry.
- (7) To promote economic service to members.

ARTICLE III – MEMBERSHIP CLASSIFICATIONS

Sec. 1. MEMBERSHIP

Membership in this Association shall be classified as Franchised, Allied, Independent and Honorary and shall be available to those otherwise qualified persons or entities which support fully the objectives of the Association as set forth in these By-Laws.

Sec. 3. SUSPENSION and EXPULSION

Any member who shall be guilty of improper conduct on or about the premises of the Association or at any event held or sponsored by the Association, or who, in the conduct of his business or in his dealings with his fellow members or the public, reflects discredit upon the Association or the industry represented by it, or who habitually makes himself objectionable to his fellow members, or who fails to support fully the objectives of the Association as set forth in these By-Laws, may be suspended or expelled by a two thirds vote of the whole Board of Directors of the Association.

I attest that I have read the requirements of membership in the VADA By-laws and understand that the failure to fully meet the requirements can result in rejection of my application and that non-compliance with these requirements following membership can result in suspension or expulsion from the Association.
